Xanana Gusmão, former President and Prime Minister of Timor-Leste, and the Eminent Person of the g7+ Association of Fragile States



José Alexandre "Kay Rala Xanana" Gusmão, commonly known as Xanana Gusmão is the most well-known and respected political leader of Timor-Leste. A former rebel, he was the first President of the independent East Timor, serving from 2002 to 2007. He then became its fourth Prime Minister, serving from 2007 to 2015. Gusmão has since held a number of officials positions including the Minister of Planning and Strategic Investment since stepping down as PM. He is also

the Eminent Person, the g7+ Association of Fragile States.

Japanese diplomat and international civil servant. His career assignment includes Director of First North America Division of the Ministry of Foreign Affairs, Minister at Japanese Embassies in the Republic of Korea and the United States, Director General of Public Diplomacy, Ambassador of Japan to the United Nations Educational, Scientific and Cultural Organization (UNESCO) and Hungary. From June 2016 to March 2020, he served as the Special Representative of the

Secretary-General of the United Nations and Head of the United Nations Assistance Mission in Afghanistan (UNAMA)

Jung Hwan Bobbi LEE, UN, Head of Office, Office of the Special Envoy of the Secretary-General on Myanmar



On Myanmar, previously represented UN Special Envoy New York Headquarters, also supported thormer Special Adviser to the Secretary-General during critical periods. Experience focused on 'hard cases' and UN inter-agency, Member State engagement on prevention efforts in politically complex environments, including during height of the Sri Lanka conflict. Has worked on democratic transitions in South Asia including in Bangladesh, the Maldives and

has backstopped UN's good offices roles in the Middle East (Iraq, Lebanon). Served in a peacekeeping field mission in Western Sahara.
