Franz BAUMANN

Prof. Taikan Oki is a Special Advisor to the President, and a Professor at Graduate School of Engineering, The University of Tokyo. His previous academic positions include Associate Professor with the Institute of Industrial Science, The University of Tokyo and Associate Professor with the Research Institute for Humanity and Nature, and also the Senior Vice-Rector, United Nations University, Japan, and an Assistant Secretary-General, United Nations. His areas of expertise are global hydrology and the sustainability of world water resources including the virtual water trade and water
